INEC's illegal attempt to deregister Youth Party

After INEC's unconstitutional attempt to deregister the Youth Party, the hearing on a suit against the Party's deregistration by the Independent National Electoral Commission (INEC) commenced at the Abuja High Court on Thursday, 27th of February.

The Youth Party's lead council, Francis Akinlotan, explained to the judge that INEC was served on January 15, 2020, and responded on February 3, 2020 but proceeded to deregister the party without regard for the matter already pending in court.

Justice I.E. Ekwo of the Abuja high court then ordered INEC to resolve the issues raised by the Youth Party regarding what the party described as an unconstitutional attempt by INEC to deregister the party, before the 20th of April, 2020. He stated that, "Nobody, including a government agency (INEC) is allowed to disrespect the court. No one is above the law".




